Family Services programs provide a continuum of behavioral health and special education services to children and their families ranging from counseling to intensive residential treatment. In FY16 these programs: operated two special education schools where 55% (105 of 192) achieved a reduction in problematic behaviors and 65% (124 of 192) students demonstrated one year or more increase in reading test scores ; assisted 97 children in the transition from a residential setting to a less restrictive environment and 60 children in the transition from a residential setting to living with a family member; provided more than 26,000 mental health assessments, crisis interventions and treatment sessions for children and families; and assisted 75 families with international adoptions, 244 families with pregnancy, parenting, and post-adoption services, 133 families with kinship caregiver support, and 69 children in treatment foster care. Gallagher Services provided support for people with developmental disabilities in 50 homes and 3 day programs. In FY16 these programs: operated vocational, supported employment and habilitation services for 175 individuals; provided adult medical day services for 33 people who require special daytime care; and were home to 246 people who live in the community and share the joys of family.

4b (Code:) (Expenses \$ 4,943,733 including grants of \$ 0) (Revenue \$ 4,508,235)

Senior Communities has developed and currently manages 24 communities providing quality, accessible and affordable housing for 1,887 residents and provides congregate housing services including meals, light housekeeping and personal care to allow seniors to continue living on their own; the Answers for the Aging program assisted 896 individuals in accessing 1,632 services in FY16. Senior Services provided medical adult day services for 101 participants, assisted living services for 60 frail senior with low to moderate incomes, long-term care communities that are leading examples of elder-eccentric care for 761 individuals.

4c (Code:) (Expenses \$ 26,701,090 including grants of \$ 2,001,020) (Revenue \$ 25,686,528)

Community Services programs provide for people impacted by poverty with shelter, transitional housing and/or job readiness or life skills workshops to homeless individuals or families. In FY16 these programs: served 589,051 meals to men, women, and children who were hungry, secured 447 housing placements for individuals who needed a stable place to live, 79% of these placements were unsubsidized; secured job placements for 341 people who were out of work, assisted 11,039 individuals with emergency, intake, and case management services; provided holistic head start programs for 918 children and their families; assisted 17 people in obtaining their U.S. citizenship; reunited 844 unaccompanied minor children with their families, provided family reunification services to 852 sponsors, and represented 1,390 clients in other immigration legal matters; taught English classes to immigrants to assist with their transition to the U.S.; and provided 2,887 welcoming, bilingual healthcare visits to 1,469 immigrants who have no other access to care.

McCarthy, Jr., Scott Becker, Mark Schulz, Mary Anne O'Donnell, Kevin Keegan, and Christopher Vaughan. Mark Schulz and Mary Anne O'Donnell each received a taxable cash payment in lieu of SERP of \$15,277 and \$11,693, respectively. For calendar year ended 12/31/15 William J. McCarthy, Jr., Scott Becker, Kevin Keegan, and Christopher Vaughan had contributions made to their SERP account in the amounts of \$27,550, \$14,496, \$12,688, and \$10,875, respectively. These contributions are currently unvested (and may never become vested) and have not been distributed (and may never be distributed). Balances in participants' SERP accounts are subject to forfeiture if the participant voluntarily terminated employment prior to his or her applicable vesting date under the agreement. In addition, under current law, interests under the SERP are reportable taxable compensation when they become vested even if those amounts are not yet payable to the participant (and even if those amounts are never paid to the participant). No rollover or other tax-deferral options are available to participants. Participants' interests under the SERP are not guaranteed or secured in any way and at all times are subject to claims of the organization's bankruptcy creditors. Cash payments in lieu of SERP and contributions to accounts pursuant to the SERP agreement are evaluated by the independent compensation consultant and approved by the compensation committee.

It has already impacted lives, as more than 30 people have been trained, certified, employed or in the process of being employed as automotive technicians. In February 2016 the organization launched Safe Streets Baltimore to curb violence on the streets of the Sandtown-Winchester community. In partnership with the Baltimore City Health Department, the No Boundaries Coalition, St. Peter Claver Parish and others, Safe Streets Baltimore is a visible presence in this neighborhood that has been disproportionately affected by gun violence.

The Archbishop of Baltimore has the authority to appoint or remove trustees as he sees fit.

Form 990, Part VI, Section B, Line 11b - The organization's Form 990 was reviewed by the Executive Committee of the Board of Directors and a copy was provided to all Board members before it was filed. The by-laws of the organization delegate broad authority to the Executive Committee.

Form 990, Part VI, Section B, Line 12c - Upon election, each director signs a conflict of interest statement requiring disclosure of conflicts of interest and signs a conflict of interest statement annually thereafter during their term. The organization's management continuously reviews and monitors to identify any area of conflict. The agency's conflict of interest policy is included in the employee handbook. Employees are provided an explanation of the conflict of interest policy during orientation and acknowledge in writing receipt of the policy at that time.

Form 990, Part VI, Section B, Line 15 - A compensation committee annually reviews the compensation level of the executive staff. Additionally, an independent firm is retained to evaluate the appropriateness of the compensation level. Minutes of the compensation committee meetings are recorded.
